Since Clínica Tepeyac began seeing patients in 1995, clinic services have expanded to include the full range of preventative and primary care services, creating a true medical home for thousands of families in the Denver metropolitan area. No less important than the quality of Clínica's programs is the culturally sensitive and appropriate nature of the care provided by Clínica staff, who truly understand and care for the community they serve.

This year we completed 14,398 visits and served a population that was 80% monolingual (Spanish-speaking). Clínica serves uninsured or underinsured, low-income, working families and, along with medical care, also provides mental health services, preventative care, and educational services that promote healthy lifestyles and families. Achievements this year include:

**Primary and Preventive Care:** Clínica Tepeyac provided over 500 well child exams and 900 child immunizations.

**Diabetes Care:** Clínica provided 3,000 patient visits that included screenings for Type I and Type II diabetes, necessary medications and medical items, and symptom management.

**Cancer Prevention:** Clínica offered screenings for breast, cervical, skin, prostate and colon cancer. We provided over 1,000 clinical breast exams, and over 900 screening and diagnostic mammograms. The Promotoras taught hundreds of women how to perform a self breast exam and about the early detection of breast cancer.

**Prenatal Care:** 169 new obstetric patients enrolled in the Clínica prenatal program. Midwives delivered the babies at either St. Joseph Hospital or St. Anthony Central Hospital.

**Health Promotion and Educational Outreach:** Promotoras conducted bi-weekly and monthly educational sessions on ways to obtain health screenings, prevent disease, understand critical health concerns, and make healthy lifestyle choices for more than 1,200 people.



**Mental Health Care:** Although this program was introduced to our list of services in 2005, the program has continued to grow, thanks to the support of volunteer mental health therapists who work closely with the medical providers. This relationship helps integrate both medical and mental health services. Volunteer therapists provide more than 20 hours of mental health appointments weekly at our Kalamath office.

**Community Partnerships:** Ongoing and successful alliances are key to Clínica's success. Partner hospitals offer care and treatment outside the scope of Clínica's abilities in its own clinic. These partners include St. Joseph Hospital, St. Anthony Hospital, Presbyterian / St. Luke's Medical Center, Denver Health and The University of Colorado Health Sciences Center. Area human services and education organizations help Clínica spread wellness and disease prevention messages through programming and / or networking. Clínica is also involved with city, regional and state government initiatives to address health disparities, and works with area health policymakers and interested foundations, such as The Colorado Health Foundation and The Colorado Trust, to implement successful health programs for the medically underserved.

**Looking Ahead:** Clínica's goals for 2010 include expanding our mental health program by hiring a bi-lingual mental health practitioner who will work closely with the clinic's other staff and volunteer medical personnel to treat the growing list of patients seeking counseling for depression and other mental illnesses. According to the U.S. Surgeon General, there are only 29 Latino mental health professionals for every 100,000 Latinos in the U.S. We also hope to exceed this year's goal of patient visits through, in part, the reconfiguration of clinic space to provide additional exam rooms.

Clínica Tepeyac has changed the lives of hundreds of Colorado families. We look forward to providing accessible and preventive health care in an atmosphere of respect and dignity, and in a culturally appropriate manner.

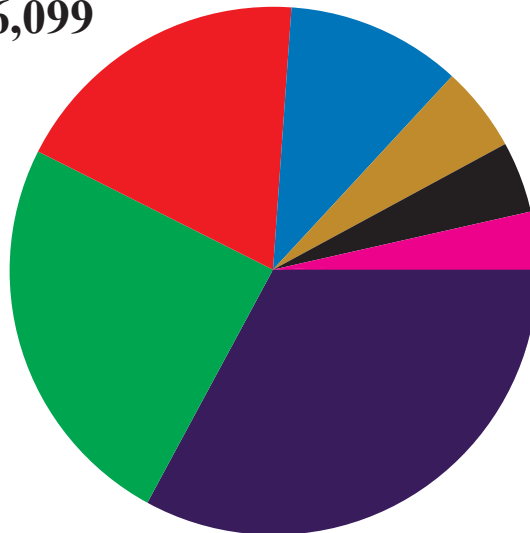
## SOURCES & USES OF CONTRIBUTIONS

*Clinica Tepeyac incurred an operating loss in 2009 due, primarily, to several large grants being “recognized” as revenue in 2008, but being spent in 2009. Contributions and other grant awards were down due to the economy, while at the same time expenses rose due to an increase in the number of patients requiring services. The budget for 2010 is projected to break even based on various cost cutting measures and several new revenue sources.*

- 32.7%** Patient Fees

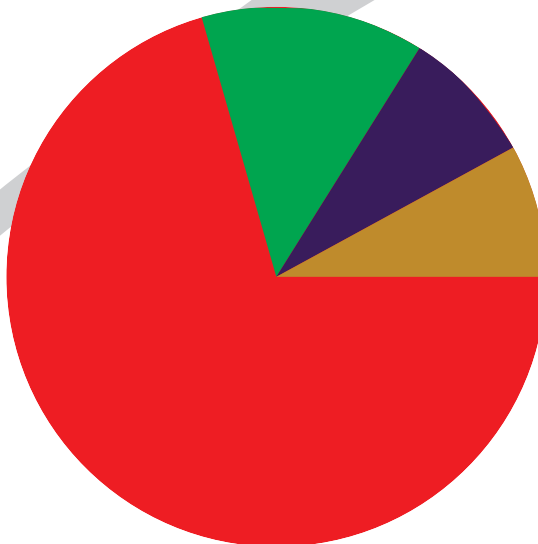
